## **CALL FOR NOMINATIONS OF CANDIDATES TO SERVE ON THE NATIONAL CONSUMER TRIBUNAL (NCT)**

The Minister of Trade, Industry and Competition hereby invites nominations of persons to recommend to the President for appointment as members of the Tribunal.

**Qualifications of members of Tribunal:** When appointing the Tribunal members the President must ensure that those Tribunal members must represent a broad cross-section of the population of the Republic; must comprise sufficient persons with legal training and experience to satisfy the requirements of section 31(2)(a) of the National Credit Act; be a citizen of South Africa, who is ordinarily resident in the Republic; have suitable qualifications and experience in economics, law, commerce, industry or consumer affairs; and be committed to the purposes of the Act.

**Term of office of the members:** Each member of the Tribunal serves for a term of five (5) years.

**Remuneration of Members:** Members will receive a fee for the work they undertake for the Tribunal.

**Note:** Background verification, including criminal record, social media and citizenship checks, will form part of the selection process. The Tribunal, taken as whole, will be constituted to take into account representivity.

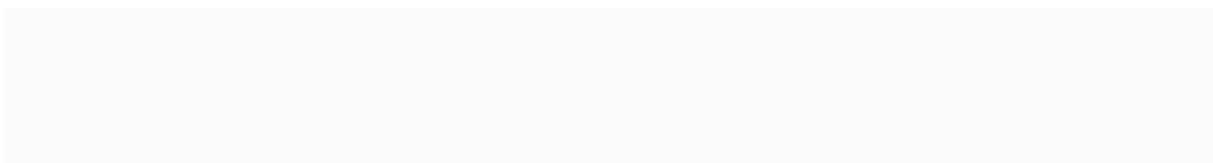
